General education candidates obtain training in the areas addressed in the previous items. All alternate licensure candidates take an introductory education class, educational psychology class, and a course addressing exceptional children. Pre-student teaching field experiences in courses help prepare candidates for working with all students. Topics on diversity, special education, ENL, and students from a variety of SES, are addressed for elementary candidates in the methods class and two classes involving literacy and literacy assessments. These topics are addressed for secondary candidates in the general methods class. Our candidates are required to have clinical experiences in diverse schools as mentioned above. In addition, the issues are addressed during the student teaching experience.

Technology is an ever-changing resource for the educator today, and Taylor works to prepare teachers to integrate technology effectively into curricula and instruction and to use technology to increase student learning. All candidates are required to develop a student teaching electronic portfolio by which candidates document mastery of InTASC principles. One requirement of the student teaching portfolio is to demonstrate the effective use of technology in the classroom in a way that enhances student learning. Another requirement is to document, chart, and analyze P-12 student learning using data, using the results in a reflective context to allow the candidate to improve instruction. Because our program is completely online, technology expertise to some degree is essential. All courses in the program implement technology, with specific emphasis placed within the elementary and secondary methods classes, in which candidates are expected to develop and apply technology, including digital resources such as webquests, digital teaching presentations, and apps.

## Teacher Training

### 1. Provide a description of the activities that prepare general education teachers to:

#### a. Teach students with disabilities effectively

All alternative licensure candidates are introduced to the concept of P-12 students with disabilities in TTT 510 Introduction to the Education Profession. Further concept development occurs in TTT 520 Educational Psychology. All candidates take SED 520 Exceptional Children, which addresses students with disabilities, gifted and talented students, and culturally and linguistically diverse students. Activities include chapter readings, test items, accommodations lesson plan, videos of special education teachers presenting information on needs, accommodations, instructional techniques, and behavior of students in special education. Candidates are required to write a narrative summary of an interview of a teacher who works with students with special needs or a parent of a student with special needs. There are numerous other assignments in Exceptional Children, including IRIS modules of case studies and assessing students with special needs. Candidates in SED 520 complete a disability simulation and write a paper on their experiences. Special education topics are also addressed in the elementary program in the methods class, in addition to the two literacy and assessment classes. In the secondary program, special education topics and issues are also addressed in the general methods class.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Candidates in SED 520 Exceptional Children read about the process of creating an IEP, what is included in an IEP, and the roles of the IEP team members, in addition to videos of special education teachers who give advice on working as a member of an IEP team. Candidates submit an assignment on the IEP process and answer test questions on the videos and chapter readings.

#### c. Effectively teach students who are limited English proficient.

All alternative licensure candidates are introduced to the concept of P-12 students who are culturally and linguistically diverse in TTT 510 Introduction to the Education Profession. Further concept development occurs in TTT 520 Educational Psychology. In addition, there are readings and assignments in SED 520 Exceptional Children. Activities include chapter readings, test items, a multicultural lesson plan, reflections on culturally responsive teaching, and readings and an assignment on restorative justice. Candidates complete IRIS modules on working with students who are culturally or linguistically diverse. Topics on working with limited English proficient and culturally diverse students are also addressed in the elementary program in the methods class, in addition to the two literacy and assessment classes. In the secondary program, topics and issues on working with students who are limited English proficient and culturally diverse are also addressed in the general methods class.

Taylor University began the Transition to Teaching program in fall 2002 in response to a state mandate for every teacher-training institution in the state of Indiana to develop an alternative path to teacher education. It was housed on the Taylor University Fort Wayne campus. When Taylor University's Board of Trustees closed the Fort Wayne campus on May 31, 2009, the Transition to Teaching program was brought to the Taylor University Upland campus to be housed in the Education Department. In 2011, the Indiana State Legislature changed the mandate to optional for providing a Transition to Teaching program for every teacher-training institution in the state of Indiana. Because TTT was a growing, successful program at Taylor University, the university decided to continue offering it as an alternative path to teacher licensure. Beginning with the fall 2009 semester, the Transition to Teaching program became an online program at the graduate level. Responsibility for the technology segment of the program rests with the Director of Taylor University Online while responsibility for the education component of the program rests with the Director of Transition to Teaching/Online Licensure Programs through the Education Department on the Upland Campus. Taylor University is proud to offer three licensure tracks: elementary (K-6), secondary (5-12), and All-Grade (P-12).
