34 CFR 668.43(a)(5)(v) - Institutional Information (public notifications for programs leading to professional licensure or certification for all modalities) (v) If an educational program is designed to meet educational requirements for a specific professional license or certification that is required for employment in an occupation, or is advertised as meeting such requirements, information regarding whether completion of that program would be sufficient to meet licensure requirements in a State for that occupation, including -

(A) A list of all States for which the institution has
determined that its curriculum meets the State
educational requirements for licensure or certification;
(B) A list of all States for which the institution has
determined that its curriculum does not meet the State
educational requirements for licensure or certification; and
(C) A list of all States for which the institution has not made
